- 1. Duluth Transit Authority (% TA+) is seeking a minimum of sixty and a maximum of eighty Cellular Modems for DTA transit buses.
- 2. Bid form must be signed by an authorized employee of the organization/company.
- 3. In submitting a Bid, Bidder agrees that acceptance of any or all Bids within a thirty (30) day period after Bid due date constitutes a contract.
- 4. The DTA intends to award a contract on June XX, 2020.
- 5. The Federal Transit Administration is providing funding for this project; the Catalog of Federal Domestic Assistance (CFDA) number is 20.500.
- 7. When signed on behalf of Organization/Company and accepted by the DTA, this pricing form and all relevant portions of the selected Vendor Bid, including any amendments thereto; the Bidder prepresentations and certifications submitted as part of its Bid; and any other relevant materials submitted by the Bidder as part of, or subsequent to submittal of its Bid shall form a binding contract between Duluth Transit Authority and the Bidder for provision of cellular mobile router pricing as specified therein.

SECTION 2. TECHNICAL/SPECIAL SPECIFICATIONS, Cellular Mobile Routers

1. The DTA is seeking qualified vendors to supply a minimum of sixty and a maximum of eighty Cellular Mobile Routers and antennas for DTA transit buses.

2. The Routers must be rated for North America providers, FirstNet Ready MP-70 modems that includes DC power cables, and support LTE, WAN, LAN, Wi-Fi, and serial connectivity.

3. Routers must include a precision GPS receiver, 4x10/100/1000 base TX Ethernet port, 1 RS232 serial port, a USB port, a configurable I/O VDC power input with Wi-Fi.

4. Routers must be commercial grade, dust and water resistant, capable of operating during bus operation without deterioration of signal during transit operations.

5. Antennas must include all cables and mounting hardware.

6. Prefer low power with a standby mode when the bus is not in use

7. Bidders must include pictures and technical specifications of the proposed unit.

8. Bidder shall provide a separate cost for delivery and a copy of all warranty provisions, as well as costs and availability of an extended warranty.

In addition, the contractor is required to return any retainage payments to those subcontractors within 30 days (or in

accordance with state law, whichever is more restrictive) after the subcontractors work related to this contract is satisfactorily completed.

Upon execution of the underlying contract, the Contractor certifies or affirms the truthfulness and accuracy of any statement it has made, it makes, it may make, or causes to be made, pertaining to the underlying contract or the FTA assisted project for which this contract work is being performed. In addition to other penalties that may be applicable, the Contractor further acknowledges that if it makes, or causes to be made, a false, fictitious, or fraudulent claim, statement, submission, or certification, the Federal Government reserves the right to impose the penalties of the Program Fraud Civil Remedies Act of 1986 on the Contractor to the extent the Federal Government deems appropriate. The Contractor also acknowledges that if it makes, or causes to be made, a false, fictitious, or fraudulent claim, statement, submission, or certification to the Federal Government under a contract connected with a project that is financed in whole or in part with Federal assistance originally awarded by FTA under the authority of 49 U.S.C. chapter 53, the Government reserves the right to impose the penalties of 18 U.S.C. § 1001 and 49 U.S.C. § 5323(I) on the Contractor, to the extent the Federal Government deems appropriate.

Safe Operation of Motor Vehicles

Seat Belt Use

The Contractor is encouraged to adopt and promote on-the-job seat belt use policies and programs for its employees and other personnel that operate company-owned vehicles, company-rented vehicles, or personally operated vehicles. The terms & mpany-owned+ and & mpany-leased+refer to vehicles owned or leased either by the Contractor or the Duluth Transit Authority.

Distracted Driving

The Contractor agrees to adopt and enforce workplace safety policies to decrease crashes caused by distracted drivers, including policies to ban text messaging while using an electronic device supplied by an employer, and driving a vehicle the driver owns or rents, a vehicle Contactor owns, leases, or rents, or a privately-owned vehicle when on official business in connection with the work performed under this agreement.

11) TERMINATION 2 C.F.R. § 200.339, 2 C.F.R. part 200, Appendix II (B)

Termination for Convenience (General Provision)

The Duluth Transit Authority may terminate this contract, in whole or in part, at any time by written notice to the Contractor when it is in the Duluth Transit Authority best interest. The Contractor shall be paid its costs, including contract close-out costs, and profit on work performed up to the time of termination. The Contractor shall promptly submit its termination claim to the Duluth Transit Authority to be paid the Contractor. If the Contractor has any property in its possession belonging to the Duluth Transit Authority, the Contractor will account for the same, and dispose of it in the manner the Duluth Transit Authority directs.

Termination for Default [Breach or Cause] (General Provision)

If the Contractor does not deliver supplies in accordance with the contract delivery schedule, or if the contract is for services, the Contractor fails to perform in the manner called for in the contract, or if the Contractor fails to comply with any other provisions of the contract, the Duluth Transit Authority may terminate this contract for default. Termination shall be effected by serving a Notice of Termination on the Contractor setting forth the manner in which the Contractor is in default. The Contractor will be paid only the contract price for supplies delivered and accepted, or services performed in accordance with the manner of performance set forth in the contract.

If it is later determined by the Duluth Transit Authority that the Contractor had an excusable reason for not performing, such as a strike, fire, or flood, events which are not the fault of or are beyond the control of the Contractor, the Duluth Transit Authority, after setting up a new delivery of performance schedule, may allow the Contractor to continue work, or treat the termination as a Termination for Convenience.
