2. Clarifications to Date:

a. The spare camera is a dome style camera

b. Copies of the site health report for the DTA Operations Center and the Duluth Transportation Center are available on the DTA website.

3. Change:

In order to ensure enough capacity at the DTA Operations Center, the Avigilon NVR will be changed from 48 TB to 128 TB.

Please change the following:

REMOVE Section 6, Technical Specifications, paragraph B1: ~~"The Operations Center Avigilon NVR will be rack mounted, minimum 48 TB, Version 7 Enterprise software."~~

INSERT: "The Operations Center Avigilon NVR will be rack mounted, minimum 128TB, Version 7 Enterprise software."

4. The new camera to be installed in the fuel lane will require new power wires and cables.

Please revise the following:

REMOVE Section 6, Technical Specifications, paragraph 2: ~~"This camera will use an existing cable and license."~~

INSERT: "This camera will use the existing license, but will require new power and data cables."

5. Please provide a price for the Avigilon Smart Assurance Plan PER LICENSE, for the one-year plan, three-year plan or five-year plan.

6. Attached is a revised bid sheet with the correct size NVR for the Operations Center and lines to propose the Smart Assurance Plan. Please REMOVE the Bid Price Sheet, page 30 of the Bid document and INSERT the revised Bid Price sheet.
