- Company name, street address, and web address (if applicable)
- Name and title of person furnishing the qualification summary
- A statement of the objectives, goals, and tasks to demonstrate responder's understanding of the project scope (see page 2)
- Demonstration of the responder's background and experience conducting similar work
- A work plan identifying the major tasks to be performed and the associated timeline
- Examples (samples) of work that are both relevant and of professional quality

DTA Photo Archive - Phase I Details

In an effort to build a robust image catalogue, a professional photographer will be hired as an Independent Contractor capturing and producing digital images of DTA team members, assets, and activities throughout the Duluth/Superior area. This will include lifestyle and product style photography. The deliverable will include 200 quality images in the context of Spring and Summer scenery and subject matter, with the DTA owning the rights to the images at the conclusion of the process.

Estimated Project Start Date: Spring 2025

Estimated Project end Date: Summer 2025

Scope of Services:

Consultant will provide technical resources and professional expertise to deliver photography services for the Duluth Transit Authority as follows:

- a. Travel to sites including DTA Operations Center, Duluth Transportation Center, Bus Garage and Maintenance facility, Bus Hubs, and other areas of understood operational and scenic importance. A conceptual emphasis will be people within the DTA organization as well as customers engaging in transit activities
- b. An agreed upon proportion of photo types/scenarios including scenery and landmarks, along with DTA infrastructure, and team members from Maintenance, Administration, and Operations.
- c. Provide equipment for photographic needs, including the ability to travel to multiple locations throughout the bus network.
- d. Communicate with DTA leadership team as needed to manage logistics including initial meeting with staff and subsequent correspondence vial phone or email.
- e. Produce and edit high quality images and submit to DTA Marketing Team for approval.
- f. Deliver electronic images as requested.
- g. This initial scope of work has the potential to become a multi-phased project dependent upon the needs of the organization and outcome of an initial project.
